- iv. Show willingness to serve and actively participate in board meetings and alumni-driven initiatives.
- v. Demonstrate strong leadership skills, commitment and active involvement in alumni or community initiatives.

The application shall be submitted online via this link: <https://forms.gle/9PHgQaCPS2JAAnLV7>, which is also available on the KCA Alumni website. The application deadline is **Thursday, 10th April 2025, at 5:00 P.M.**

Applications will be vetted by an ad hoc independent committee appointed by the University Senate Committee in charge of Student Welfare (Section 9.5). The review process will be rigorous to ensure that only qualified candidates are presented for election at the upcoming **Annual General Meeting (AGM) on 26th April 2025**.
